# Besore Library Bioswale

As funded through a state grant, in 2021 the Borough completed a collaborative project with the Besore Library to install a bioswale on the library property.

A bioswale is a shallow depression that holds runoff. As seen in the photo at right, the Besore Library bioswale is planted with specially selected native vegetation that will filter runoff, as well as increase infiltration.

Bioswales reduce the amount of runoff and remove pollutants. As the water pools in the depression, it can infiltrate deeper into the soil, or be used by the vegetation.



#### MS4 Workgroup

In 2020, the Borough created the MS4 workgroup as an advisory, information gathering, and action planning group. The workgroup is comprised of community members as well as the Mayor, Borough staff, and several Council members.

# Stormwater: SPIF & MS4

Stormwater is the water that runs off land after precipitation. The Borough manages stormwater through a system of inlets, piping, and water quality improving structures. The primary role of the Borough's stormwater system is to protect property from flooding and water damage.

To better support stormwater infrastructure maintenance and fund capital improvement projects, the Borough implemented a Stormwater Pollutant Impact Fee (SPIF) in May 2019.

Through this fee, all Borough properties are charged a quarterly amount based on the mapped impervious coverage of each parcel. Examples of impervious areas include structures, driveways, private sidewalks, and gravel.

The Borough is designated as a Municipal Separate Storm Sewer System (MS4) community. In May 2020, the Borough of Greencastle received a waiver allowing a five-year exemption from the MS4 mandated requirements. The current waiver will expire in May 2025.

# 2022 Stormwater Budget

The 2022 stormwater budget included a \$0.25 increase in the SPIF rate. This rate change will increase the fund's annual revenue by \$30,000 and impacts the average residential property SPIF billing by \$2.00 per quarter

# Impacts on Our Borough

Below are simple tasks all Borough residents and property owners can do to improve stormwater quality.

#### Lawn Chemicals

Use chemicals like fertilizers and pesticides only according to instructions on the product.

#### Pet Waste

Always pick up after your pet and ensure no waste is discarded in or near inlets

#### Car Maintenance


Do not wash your car where it will drain into the stormwater system.

# 2022 Budget Highlights

The 2022 budget maintains municipal services at the same level residences experienced in 2021.

The 2022 budget had no increase in the property tax millage rates, with the last increase occurring in 2018.

#### American Rescue Plan Act

This legislation was signed into law in March 2021 and allocated \$1.9 trillion in aid to combat the COVID-19 crisis. The Borough's American Rescue Plan Act (ARPA) allocation is \$417,211.48.

2022 Budgeted Uses of ARPA:

- \$90,000 to Rescue Hose Co
- \$60,000 for stormwater infrastructure improvements

No open burning is allowed between the hours of 6:00 pm to 7:00 am.

#### **CHAPTER 130 - NOISE**

Operation of machinery or equipment is prohibited between the hours of 11:00 pm and 7:00 am.

# **CHAPTER 132 - MAINTENANCE**

All weeds, brush, or grass in excess of 10 inches in height is a violation.

# **CHAPTER 205 - ZONING**

All alteration, reconstruction, and demolition work requires an approved land use permit.
