The secretary turned in \$ 88.05 for collection of tax on poles and other items. On motion the above reports were approved.

Tax Collector, B. H. Daley presented a list of delinquent tax-payers, and was instructed to take necessary steps to prevent loss to the town by entering all necessary accounts.

Police Chief, Ambrose, reported one arrest for the month. Fines of \$ 5.00 were turned over by W. S. Hostetter, J. P.

On motion the treasurer was instructed to withdraw the amount of \$ 2000.00 from the borough checking account and to place same on time deposit in the form of two \$ 1000.00 certificates.

Pres. Gardner reported negotiation in progress with the gas Company. Explained that the rates proposed were much in excess of rates asked a few years ago and for that reason were not satisfactory. Further consideration was to be given the matter.

Mr. Gardner & Mr. Stover reported a conference with Borough Attorney Hoke relative to the Johnson water suit, and stated that borough council was prepared to file an answer within a few days.

On motion, the Street Committee was authorized to secure the services of a surveyor for the purpose of locating property lines and grades in front of the properties of Rahauser's et al. where proposed side-walks are to be laid.

A motion was also passed authorizing assistance in the form of unskilled labor to all person desiring to build new side-walks. This offer to expire March 1st. next.

Row W. Stover, of the Water Committer reported extensive improvements at the reservoir. The main pipe-line from the Eshlman Sprin has been re-laid and made water-tight; the old resevoir drained, and a system of drain tile being installed.

Mr. Hoachlander, of the Street Committee was authorized to carry out the recommendation of the state highway department for the installation of two 15 in drain pipes on East Baltimore Street, between Linden and Spring Grove Avenues.

Following a brief discussion Mr. Hoachlander was authorized to purchase a second-hand dump truck from Mr. G. C. Fox for the sum of \$ 75.00; same to be for the use of the street and water departments or other borough work.
