Regular Meeting, Council Hall, January 7, 1935; 7:00 P. M.

The regular January meeting of Council was held on the above date with the following present:-

Burgess D. W. Shinham, and Councilmen Stover, Friedly, Davison, Hoachlander, Seibert, Walck & Gilland.

Minutes of the last regular meeting were read and approved.

Boro. Treasurer Chas. W. Bert, Jr. reported as follows:-

Balance in Borough account, - - - \$ 1748.24 Balance in Bond account, - - - \$ 2442.87

Police Chief, Ambrose made a detailed report of police activities for 1934. The report indicated that 115 arrests were made, and a total of \$ 325.75 in fines collected. The police's report for December gave 11 arrests, and \$ 10.00 in fines collected.

On motion, the above reports were approved and accepted.

Burgess Shinham stated that in view of the fact that the police Chief had been using his car for borough purposes that he would recommend that the car be titled in the name of the borough. In this manner there would be no expense for the license. No action was taken.

The gas company was given permission to use city water in removing dirt from pavements caused by their excavations. Water manager Bert was authorized to refund the following:-

Mrs. Brewer, \$ 3.84; to Mrs. Mary Lear, \$ 3.09

The water manager also stated that in the course of the survey conducted by Mr. Tenley, 186 leaks of various sorts had been stopped. Also that the total cost of operation of the Moss Spring station for 1934 was \$ 1004.83

On motion, the Fire and Water Committee was authorized to purchase two new batteries for the Brockway truck.

On motion of Mr. Stover, seconded by Dr. Gilland, a charge and deposit for the loan of Borough hose was levied as follows:-A charge of 50 ¢ per section for the first day, and 25 ¢ per sec. for each additional day. Before hose are allowed to be taken out, a deposit of \$ 3.50 per section must be made, and upon return of the same in satisfactory condition, the difference between the amount deposited and the amount of the service charges accrued shall be refunded. A minimum charge of 50¢ per section shall be made, and the time charged for shall be computed from the time the hose are taken out until they are returned.

Pres. Walck appointed Messers Seibert, Friedly and Hoachlander to be additional members of the committee to devise ways and means of securing financial aid for our fire department from Antrim township and the surrounding villages.

On motion Mr. Hoachlander, seconded by Mr. Dr. Seibert, the Citizens National Bank was designated the depository for all borough funds for the year beginning Feb. 1, 1935 and ending Feb. 1, 1936.
