With respect to this matter, the following resolution was introduced by Mr. Stover, seconded by Mr. Davison, and unanimously passed by Council:-

"I hereby introduce an ordinance entitled, 'An Ordinance ordaining, laying out, opening and extending certain streets and alleys in the plot of ground laid out by the Greencastle Realty Company, whose plot is recorded in the Deed Records of Franklin County, Pennsylvania, in Vol. 223, Page 41.'

I hereby move that the above ordinance be held over until the regular meeting of the Borough Council to be held on May 6th. 1935, upon which date at 7:30 o'clock, p. m. at Council Hall, the Council will hear any objections that may be offered to the passage of said Ordinance, and that the Secretary be instructed to post notices of the time and place of meeting along the lines of the streets and alleyes designated in said ordinance, at least ten (10) notices to be posted upon each street and each alley; and further that the said ordinance be published in the Echo-Pilot once a week for three consecutive weeks beginning with the issue of April 4th. 1935."

On motion of Dr. Gilland, seconded by Mr. Stover, the secretary was instructed to notify Mr. B. H. Daley, tax collector, that in the future, and for 1934 taxes, that the proceedure outlined in the Act of May 29, 1931, P.
