

ORDINANCE NO 2009-002

AN ORDINANCE OF THE BOROUGH OF GREENCASTLE, FRANKLIN COUNTY, PENNSYLVANIA, AMENDING CHAPTER 190, SECTION 9 OF THE CODE OF THE BOROUGH OF GREENCASTLE ENTITLED, "SPEED LIMITS ESTABLISHED" TO INCLUDE ADDITIONAL STREETS WITH THEIR RESPECTIVE SPEED LIMITS

WHEREAS, the Vehicle Code, 75 Pa.C.S. §3362 (a)(1.2) and §3363 authorizes Pennsylvania municipalities, subject to 75 Pa.C.S. §6109 (e), to set the speed limit at twenty-five (25) miles per hour on certain local highways without a prior engineering and traffic study; and

WHEREAS, certain local highways within the Borough of Greencastle (the "Borough") are in a residential district and are not a numbered traffic route; and

WHEREAS, the Council of the Borough of Greencastle deems it to be in the best interests, and for the general welfare, of the citizens and residents of the Borough to enact twenty-five (25) miles per hour speed limits on certain local highways in the Borough pursuant to the Vehicle Code; and

WHEREAS, the Council of the Borough of Greencastle desires to affirm various other speed limits which were established, posted, and enforced prior to July 1, 1977.

NOW THEREFORE BE IT ENACTED AND ORDAINED, by the Mayor and Borough Council of the Borough of Greencastle, Franklin County, Pennsylvania, and it enacted and ordained as follows:

SECTION I: Chapter 190, Section 9 entitled "Speed Limits Established" Subsection (A) thereof of the Code of the Borough of Greencastle, is hereby amended and shall read as follows;

A.

The following speed limits are hereby established;

SECTION II: Enforcement. Subsection (B) of the Chapter 190 of the Code of the Borough of Greencastle, Section 9 thereof, shall be amended as follows:

B.

This Ordinance shall be enforced by the Greencastle Borough Police Department or any other authorized police officer in accordance with the Vehicle Code of Pennsylvania as it pertains to fines and other penalties.


SECTION III: Repealer. All provisions of previous Ordinances of the Borough of Greencastle which are contrary to this Ordinance are expressly repealed.

SECTION IV: Savings Clause. In all other respects, Chapter 190 of the Code Borough of Greencastle shall remain as previously enacted and ordained.


SECTION IV: Effective Date. This Ordinance shall take effect immediately.

ENACTED AND ORDAINED this 8th day of September 2009 by the Council of the Borough of Greencastle, Franklin County, Pennsylvania.


