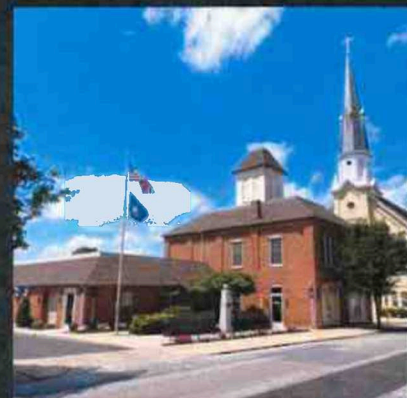

January Updates

Tele-Plus has successfully installed new traffic cameras at the intersection of Route 11 and Route 16 (Northeast side) to enhance public safety and improve traffic monitoring. These high-resolution cameras will assist the department in managing traffic flow, conducting accident investigations, and ensuring overall roadway security. The system provides real-time footage, enabling officers to respond more efficiently to incidents, identify traffic violations, and gather critical evidence when needed. Additionally, these new cameras, in conjunction with the existing PennDOT cameras, provide the department with an expanded view of the intersection and surrounding areas, significantly enhancing situational awareness and response capabilities.

Furthermore, a new camera has been added to the kitchen area, providing coverage of the new server for the camera system as well as the ammunition and gun storage closet. This addition enhances security within the department, ensuring that critical areas are monitored and safeguarded.

The police department has implemented a new evidence collection system designed to streamline the process of logging, tracking, and managing evidence more efficiently. This system enhances organization, improves accuracy, and ensures compliance with best practices for evidence handling. In addition to integrating this new technology, Officers Knopp and Miller are actively working on updating existing evidence records to maintain accurate documentation and improve case management. These updates will help ensure that all evidence is properly cataloged and readily accessible when needed for investigations or court proceedings.
