Community Involvement

On August 12th, Officer Morrow represented the Greencastle Police Department at the Back-to-School event hosted by the Greencastle Church of the Brethren.

Training

Training – On August 26th, the Greencastle Police Department hosted a Taser 10 certification class presented by AXON Master Instructor Sgt. Ed Plummer of the Hagerstown City Police Department. During this course, four GPD officers were certified as Taser 10 instructors. Officers also had the opportunity to deploy and train with the department's recently purchased Taser 10 devices through multiple practical exercises. In addition, participants utilized AXON's Virtual Reality (VR) headsets to engage in scenario-based training and testing.

As part of the training, an opportunity was offered for voluntary exposure to the new Taser 10 platform. I elected to participate in this exposure.
