Reports from Elected Officials

Mayor's Report

Mayor Thomas reported on recent community activities, including the conclusion of the 42nd Triennial Greencastle-Antrim Old Home Week and ribbon-cutting ceremonies for local businesses. Thomas highlighted the

Community Service Citation presented to the Paul and Anna Shockey Foundation in recognition of their contribution to the Town Hall Plaza Project. Mayor Thomas was also joined by Waynesboro Mayor Dade Royer, who referenced a friendly wager between the two Mayors on their respective high school football teams, which resulted in Mayor Thomas wearing a Waynesboro Indians shirt during the meeting.

On a Burkholder/Reagan motion, the Council unanimously voted to support the Mayor's recommendation for the creation of a task force for the mitigation of downtown thru truck traffic.

Police Department Report

Chief Batistig reviewed the August 2025 calls for service and highlighted community involvement and training initiatives. Officers participated in a local Back-to-School event to strengthen community relationships, while four officers were certified as Taser 10 instructors during a training session that included practical exercises and virtual reality scenarios.

Manager's Report

Little provided an update on current and upcoming projects and distributed the publicly advertised 2026 Budget Meeting Schedule. Little reported on the Town Hall Plaza project, noting the successful donor recognition ceremony held at the plaza lot on August 27. Little also reviewed the recent sycamore tree inspection report and identified an upcoming unbudgeted sewer replacement project on the Colonial Drive force main.

President's Report

President Faight identified the donation in the amount of \$300,000.00 received from the Paul and Anna Shockey Foundation in support of the Town Hall Plaza Project and thanked Councilman Albert Miller for his efforts related to the plaza project.

On a Reagan/Stenger motion, the Council unanimously voted to approve the employment of Christopher Buterbaugh to fulfill a part-time Police Officer position conditional on the satisfactory completion of all preemployment evaluations and background confirmations.
