 - b. No parking – north side of Center Square starting at 6am
 - c. Approve a waiver of Borough Code § 190-30, allowing food truck parking on the above requested streets while closed

Approve the request submitted by the Greencastle-Antrim School District for a waiver from the requirements of §180-10 of the Borough Code to allow submission of the land development plan titled *New Field House and School Additions* as a combined preliminary/final plan as recommended by the Planning Commission.
