March Updates



Training

Training – On March 2 and 3, GPD conducted our annual MIST training. Officers successfully completed the required MPOETC curriculum for 2026. During the training, those officers who had not previously been trained on the Taser 10 platform were certified and are now authorized to carry the Taser 10 while on duty.

Additionally, utilizing the ALERRT training that Officer Kamoie received last year, the department reviewed and demonstrated room clearing tactics and movement techniques through various scenario-based exercises to reinforce communication and coordination during critical incidents.



Academy

Cadet Pepple continues to excel both physically and academically in the academy. Cadet Pepple recently participating in the Semper Gratus “Always Grateful” - 5K run. Cadets are encouraged to engage in community events that strengthen community relations and present our profession in a positive light.

Calls for Service and Notable Incidents

March 31 – GPD received multiple complaints regarding unlocked vehicles that had been entered and items removed. Through the use of the Borough camera system and social media, a suspect has been developed. The investigation remains ongoing. An informational flyer was also posted on social media, reminding citizens to lock their vehicles and remove valuables.

Carl's Drug Store - Additional charges have been filed related to the other burglaries at the store, including a Christmas Day incident and an attempted burglary. I would like to recognize and thank Officers Knopp, Morrow, and Brennan for their efforts, as well as the Franklin County Drug Task Force, the Washington County, Maryland Narcotics Force, and the DEA and PSP for their assistance and collaboration in this investigation.
