

Regular Meeting, Council Hall,  
November 5, 1934, 7:30 P. M.

The regular November meeting of Council was held on the above date with the following present:-

L. R. Walk, President, and councilmen Gilland, Seibert, Stover, Hocahlander, Davison, & Friedly.

Mr. David Walters appeared before Council and asked that a street light be placed on the west side of the R. R. Bridge on S. Carlisle Street extended.

A committee from the Rescue Hose Company made a request for supplies and equipment including 500 ft. 2 1/2 in hose; 300 ft. 1 1/2 in. hose; 6 pr. boots; nozzels, reducers, etc.

Police Chief Ambrose stated that he had secured prices from the city of Hagerstown for a light to be used in Center Square in place of the traffic blinker. The price was quoted at approximately \$ 25.00

Minutes of the last regular meeting and one special meeting were read by the secretary, and approved as correct.

Borough Treasurer, Chas. W. Bert, Jr. reported as follows:-

Police Chief, Ambrose reported six arrests for the month.

On motion, the above reports were approved.

The Water Manager reported water collections for this year \$ 534.58 in excess of the same period last year.

On motion \$ 400.00 was ordered transferred to the borough account from the bond account; this being payment of loans made during the past few months.

On motion, the Water Manager was authorized to refund to Mrs. P. E. Baer the sum of \$ 6.50. This refund being on her water account.

The Water Department was authorized to purchase one complete

fire hydrant, and other supplies that may be advisable.

On motion Dr. Seibert, seconded by Mr. Hoachlander, the purchase of 500 ft. 2 1/2 in hose and 6 pr. boots was authorized.

Following discussion on the subject, Pres. Walck appointed a committee comprising Messers Gilland, Davison and Stover, to confer with the Antrim Supervisors and to take necessary steps toward having them contribute a certain yearly amount toward the upkeep of our fire department.

The Street Committee was authorized by motion to proceed with repairs to the Humbert Alley, Rinehart, gutter, N. Elm Lane and several other minor repair jobs.

On motion of Mr. Davison, seconded by Mr. Friedly, the Street committee was authorized to investigate conditions of S. Church Street, and E. Franklin Street, and if advisable make plans for submitting repairs and improvements to same as a work project.

The Light Committee was instructed to further investigate the matter of replacing the Center Square traffic signal with a white-way lamp.

A letter was read from the Greencastle Realty Company in which the said company agreed to deed the title to all streets and alleys in the section owned by them to the Borough. The consideration being \$ 1.00; and the Borough to agree to prohibit the erection of poles on the streets and meet certain other conditions. On motion, the proposition was accepted, and the secretary instructed to have the Borough attorney attend to all legal matters with regard to the transfer.
